

In response to a request, we have developed a report to show the number of district court civil cases that have a domestic violence issue with an issue order date entered. A case may have multiple domestic violence issues. If a case has more than one domestic violence issue, it is only counted once in this report. Therefore, for the purposes of this report, a rank is imposed on the domestic violence issue orders. The issue orders within a case are sorted by ranked order and then by descending issue order date. [In other words, the first issue order in this sort is retained; all other issue orders in the case are dropped from the report.] Of the retained issue orders, one per case now, only the cases with issue order dates within the report period are counted.

This table shows the issue order codes used by the clerks and how they are ranked for this analysis:
