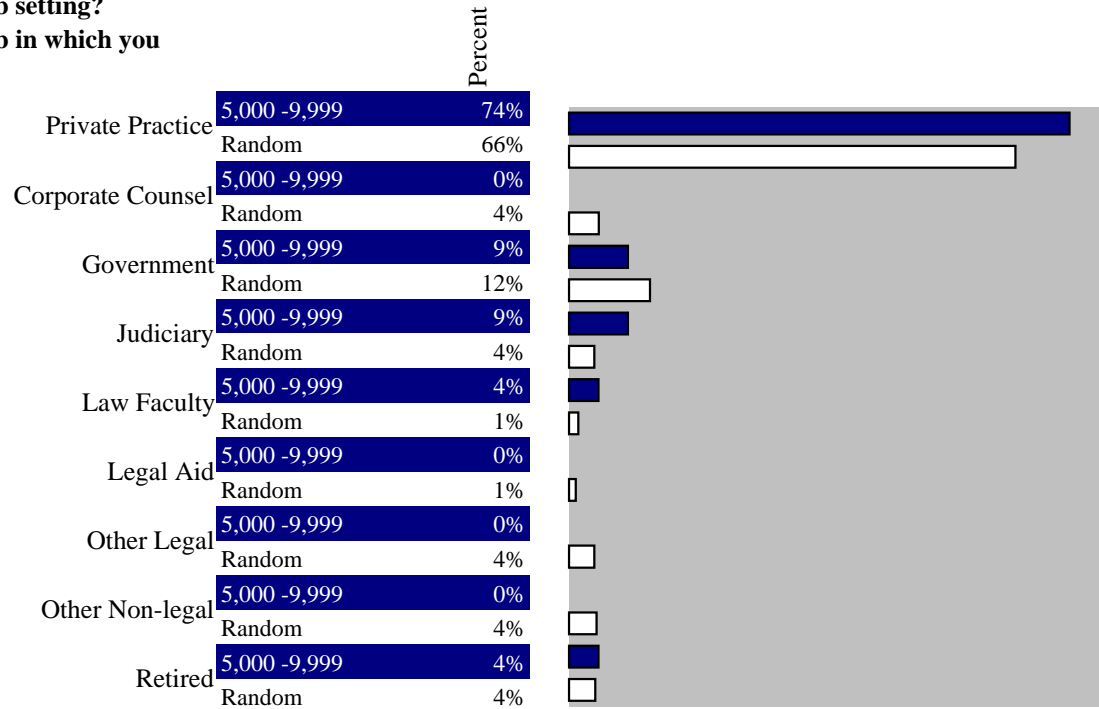

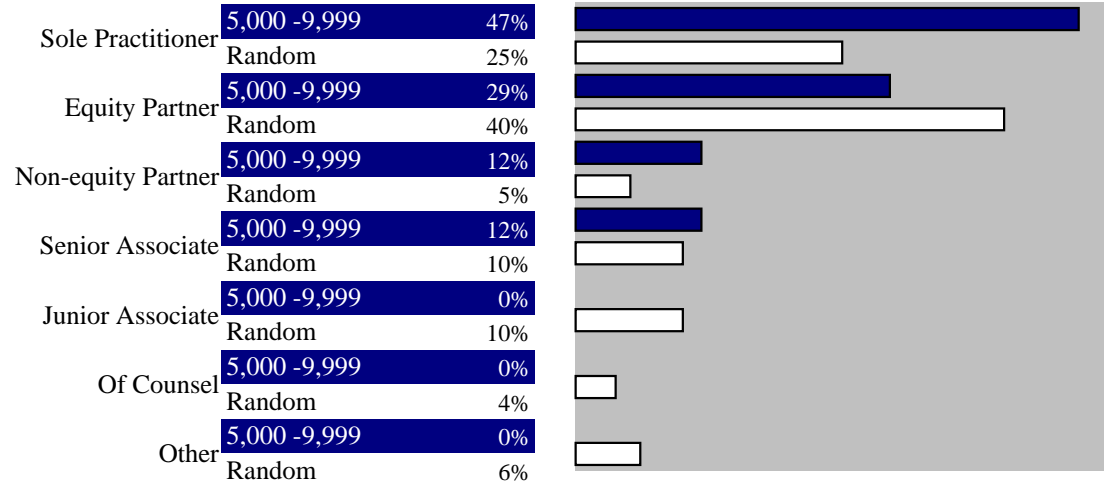

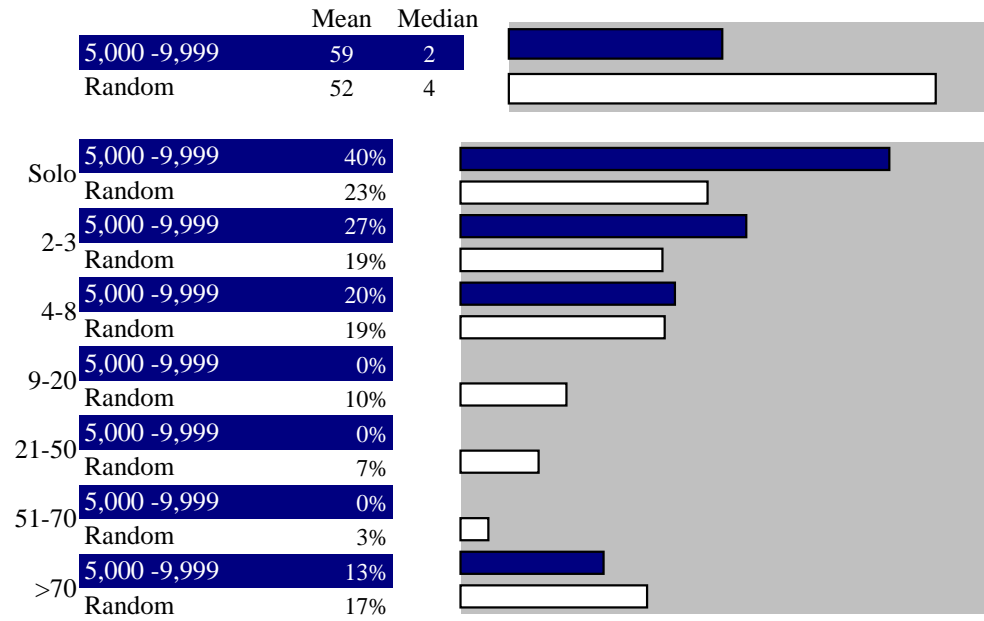
**Which of the following best describes your current job setting?

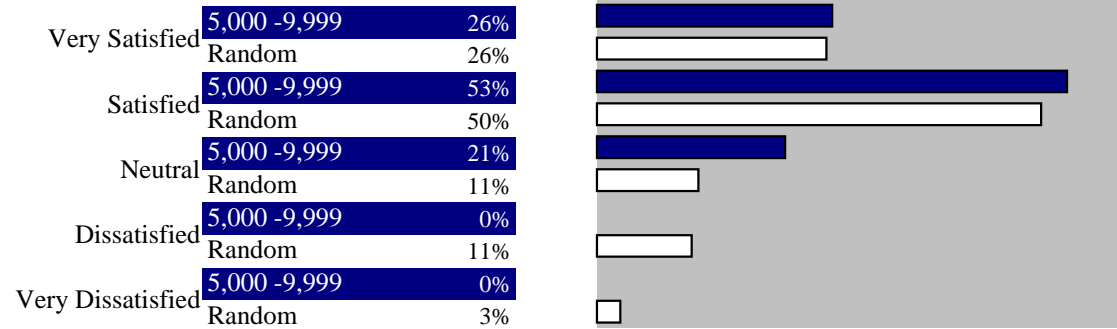

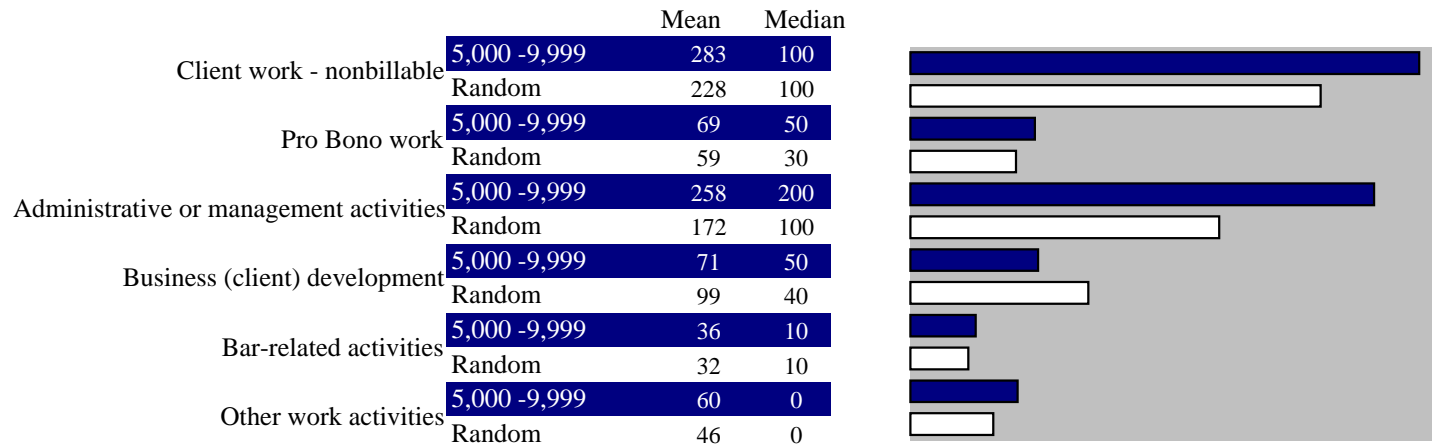

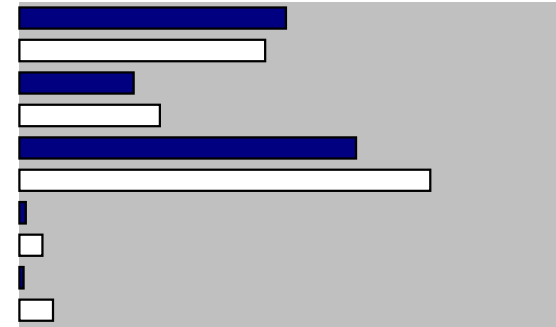

**How many nonbillable hours do you expect to work during 2002 in each of the following categories:**



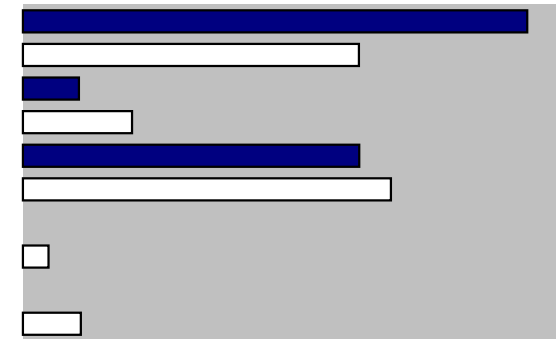
