The Administrative Office of the Courts is pleased to make these forms available to the public, attorneys and various advocacy groups via the Judicial Department website. We encourage you to use the website to complete and print forms whenever possible. **Please note that you cannot submit forms to the court electronically.** AOC forms are under constant review and not all forms are available on the website at this time. The Judicial Department website address is www.nccourts.org. Select the “Forms” tab just beneath the banner at the top of the page to bring up the Judicial Forms search engine and follow the directions.

- (2) If the § symbol is followed by an F, the form is at least partially fillable from the website.
- (3) Red text indicates that the form is recently revised or is new.

The forms in this list are available in portable document format (PDF) for the public and other users on the Judicial Department website, www.nccourts.org. Many of the forms are fillable from within your web browser or may be saved to your computer and used without accessing the Internet each time. Adobe Acrobat Reader, a free software package available from www.adobe.com is required to access and complete fillable forms. **You cannot access the forms directly from this list; you must first access the forms search screen at <http://www.nccourts.org/Forms/FormSearch.asp>.** Follow the instructions on the screen.
