The arbitration hearing must be held on that date or within sixty (60) days of the filing of the last responsive pleading. Any continuance beyond the sixtieth day may be granted only by a judge upon written motion and a showing of a strong and compelling reason to do so.

If settlement is reached prior to the hearing date, the parties must notify the person named below before the hearing date so that the hearing may be cancelled.

Failure to appear for the hearing may result in an adverse award and/or sanctions. See Rule 3(l) of the Rules For Court-Ordered Arbitration.

G.S. 7A-37.1(c1) provides, "In all cases referred to nonbinding arbitration..., a fee of one hundred dollars (\$100.00) shall be assessed per arbitration, to be divided equally among the parties." This fee must be paid promptly upon completion of the arbitration hearing, in the amount assessed. If any party does not pay, the amount assessed will be docketed as a judgment in favor of the State when the award is filed.
