2. I have been of good behavior since the adjudication.
3. I have attached to this petition **two** verified affidavits of good character, pursuant to G.S. 7B-3200(c)(2).

4. The offense for which I was adjudicated delinquent would not have been a Class A-E felony if committed by an adult.
5. I have been released from juvenile court jurisdiction.

At least eighteen (18) months have elapsed since I was released from juvenile court jurisdiction and I have not been adjudicated delinquent again or convicted as an adult of any felony or misdemeanor other than a traffic violation under the laws of the United States or the laws of this State or any other state.

2. An order be issued to expunge the records of the adjudication as provided by G.S. 7B-3200.
