THIS MATTER COMING ON TO BE HEARD upon pre-trial conference before the undersigned Presiding Judge upon pleadings seeking a determination of marital property and an equitable distribution of such property as shall be determined to be marital;

AND IT APPEARING that the parties have reached agreement on certain facts and on certain issues and have delineated the areas of agreement and disagreement;

AND IT APPEARING that by their signatures affixed hereto, each party stipulates that he or she agrees with the facts and issues classified as agreed upon and stipulates that the facts and issues classified as being in dispute are accurately reflected and that there are no other issues to be determined by the Court;

AND IT FURTHER APPEARING that each party by signing this Pre-Trial Order warrants and avows that he or she has disclosed the existence of all property, both separate and marital, to which he or she may have a claim at the date of valuation of marital property, regardless of to whom such property may be titled or in whom actual ownership may be designated. Said disclosure has been full and honest and is free from taint or fraud;

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED and stipulated as follows:

12. Schedule F is a list of Plaintiff's contentions why equal division is not an equitable division. (Use only if Plaintiff in this action and you do not seek equal division.)

13. Schedule G is a list of Defendant's contentions why equal division is not an equitable division. (Use only if Defendant in this action and you do not seek an equal division.)

14. Plaintiff and Defendant have added additional schedules needed to state other issues to be decided by the Court. They are labeled _____

15. The parties shall submit affidavits of expert witnesses intended to be called at trial to counsel for the opposing party no later than _____.

- The Judge shall rule on issues raised in Supplemental Schedules attached hereto.
