

**Information about Concealed Handgun Permit Appeals**  
**(N.C. Gen. Stat. § 14-415.15)**

A person appealing the Sheriff's decision to deny, revoke, or not renew a concealed handgun permit must file a written Petition and Notice of Appeal with the **Clerk's Office in Room 107** and pay the required court filing fees for this administrative appeal. You may use, but are not required to use, the local form found online, CCLF-CV-17.

You must give the Sheriff's Office a copy of your filed Petition and Notice of Appeal.

You must also bring a copy of your filed Petition and Notice of Appeal to **Shannon Callis in Suite 307** to obtain a court date. Ms. Callis is responsible for scheduling your appeal on the motions calendar for the next civil session of **District Court**. It is your duty to furnish us with your correct mailing address. We will send to you and the Sheriff by regular mail a Notice of Hearing setting your court date. If you have questions about the scheduled court date, you may contact Ms. Callis at 910-475-3262.

If you have further questions, please be advised that court personnel cannot give legal advice; rather, you should contact an attorney.
