Motion for Show Cause Order (Contempt)

The Family Court Staff <u>can</u> give you basic legal information about the process. The Family Court Staff <u>cannot</u> give you legal advice. They cannot tell you which forms you should file, what you should specifically write on the forms or what the Court will do.

Steps for filing a Contempt Action

Complete these forms:

- 1. Motion for Order to Show Cause and Contempt
 - *Plaintiff and Defendant remain the same as listed on the Court Order
- 2. Order to Appear and Show Cause complete top section only



Sign the Motion in the presence of a Notary Public.

The Family Court Office does <u>not</u> have a Notary



Make two copies of each form.



Take the completed Motion (and copies) to the Clerk of Court. There is a \$20 filing fee unless you qualify for a waiver.

- •The Clerk will keep the original Motion for the court file and return the clocked copies back to you.
- •If you do not have a copy of the current Court Order, you may obtain it from the Clerk of Court.



Bring the follwing to the Family Court Office:

- •One clocked copy of the filed Motion for Show Cause & Contempt
- •The Show Cause Order with top section completed (original plus two copies)
- •A copy of the current Court Order that you beleive has been violated.



Family Court Staff will present your Motion to a judge for review. You may need to leave your materials if a judge is not immediately available. Family Court Staff will contact you once the judge has reviewed your Motion and signed the Order.



File the Order to Show Cause with the Clerk and Serve a copy of the Motion (with attachment) & Order on the other party:

- •by Sheriff (fee may be required) or
- •by Mail (Certificate of Service must be filed with the Clerk of Court)
