All persons in jail will be heard by video. If a plea transcript needs signing go to the jail ahead of time.

There will be a private video transmission available beside courtroom 1 if attorney’s need to contact the client the day of the hearing.

Judge Ervin said if the need arises during the hearing to speak to your client privately then the State and the court will leave the courtroom to allow that conversation to proceed.
