The undersigned Senior Resident Superior Court Judge for Superior Court Judicial

District 11B and Chief District Court Judge for District Court Judicial District 11 enter this

Administrative Order pursuant to Chief Justice Cheri Beasley's prior Administrative Orders in
response to the COVID-19 (corona virus) epidemic. This order is entered with the consent of
Johnston County Sheriff Steve Bizzell and applies to those individuals who previously have been
adjudicated guilty in a Superior or District Court of this State and ordered to serve sentences
under NCGS 15A-1351 (which sentences are commonly known as "split sentences" or "weekend
sentences") in the Johnston County Detention Center.

It is hereby ORDERED as follows:

- 1. Effective 23 March 2020, those individuals ordered to serve split sentences, whether the sentences were ordered to run for a continuous period ("straight sentences") or for intermittent or non-continuous periods of confinement, who are not currently housed in the Johnston County Detention Center shall have their split sentences temporarily suspended and shall not report for confinement as previously ordered.
- 2. Those individuals currently in the custody of the Johnston County Detention Center solely under a split sentence shall be released immediately and shall complete any remaining periods of confinement pursuant to the provisions of this order.
- 3. This order suspending split sentences shall expire on Friday, 24 April 2020 at 5:00 pm, unless this order is extended or otherwise modified by the undersigned judges.
- 4. Upon the expiration of this order or any extension of this order, the probation and parole officers assigned to supervise the individuals subject to this order, after conferring with the Johnston County Detention Center Administrator about jail capacity, shall reschedule the confinement periods for those individuals as necessary to complete the split sentences imposed. A judge may extend an individual's term of supervised probation if necessary to complete a split sentence.
 - 5. Prior to their admission to the Johnston County Detention Center, all individuals
